**REGULAR MEETING**

The Mt. Pleasant City Council held a regular meeting November 9, 2010 at 7:30 PM. The meeting was held in the Council Chambers, 115 West Main, Mt. Pleasant, Utah.

1. **Welcome** - Mayor Sandra Bigler welcomed everyone to the meeting.
2. **Opening Ceremony / Pledge of Allegiance** - Council Member Monte Bona led the group in the Pledge of Allegiance.
3. **Roll Call** - Mayor Sandra Bigler, Monte Bona, Reed Thomas, Justin Atkinson, Mike Hafen, Mark Andrew Beach - Others Present: Three members of the community and Shane Ward from the power department.
4. **Approval of Agenda Items** - Mayor Sandra Bigler moved to table agenda item #8, dealing with the metering of Doug Draper until the regular meeting scheduled for November 23<sup>rd</sup>. All approved. A motion to approve the amended agenda omitting item #8 was made by Monte Bona and seconded by Justin Atkinson. All voted in favor.
