Mt. Pleasant City Ordinance 3-1C-8 Late Payment Penalty

a. All license fees not paid by 1st of February of each year shall be increased by 5% of the total license fee due. License fees not paid by the 1st of March of each year shall be increased by 10%. License fees not paid by the first June of each year shall be increased by 50% of the total license due.

b. When a business fails to apply and pay for a business license by the first of June, the city recorder shall send a letter to the owner of the business asking him to comply with this article within (5) days from the date shown on the letter. In the event the owner/operator fails to comply, the city recorder shall refer the matter to the chief of police and the city attorney.
