The Mt. Pleasant City Council held a regular meeting August 28, 2018 at 4:00 p.m. The meeting was held in Council Chambers, 115 West Main Street, Mt. Pleasant, Utah

**Time was turned over to the city council to appoint a Mayor Pro Tempore to conduct the rest of the meeting. Councilman Dan Anderson was appointed Mayor Pro Tempore to conduct the rest of the meeting.**

**3. Approval of Amended Agenda Items:**

Keith Collier moved to approve the amended agenda of August 28, 2018.

**4. Approval of Claims and Requisitions:**

**6. Acceptance of Public Works Directors Resignation**

A resignation was received from Sam Draper, the Public Works Director. Appreciation was expressed for all the work he has done for the city. He will continue as the City Fire Chief. Colter Allen will be the Public Works Director until the council is able to determine what direction to go. No motion was made to accept this resignation as per a council member stating that it had already been accepted on the 21<sup>st</sup> of August.

Councilman Stallings made a brief statement. He explained that they as a council are obligated to accept these resignations. Those who have resigned should have their privacy respected. The council is grateful that both are willing to continue on as the Sexton and Fire Chief.
