7. Discussion/Action: Water Connection Outside City Limits

This refers to Dwayne Watson attending City Council requesting to connect into the city water supply. At the last City Council Meeting this item was tabled so that the council could have more time to investigate the situation. Since that time Colter has checked the pressure and it is at 42lbs. Mayor recommends not allowing the connection into the city main line at this time. Councilmembers Keisel and Black agree with the mayor. There was also a brief discussion on where we are at on the water project, to see if down the road there might be the option to offer him water. Councilmember Draper says he feels it would be best to say no now and tell him it could be reevaluated in the future, depending on the water project. Councilmember Atkinson sees it being beneficial to provide the services to those above the city in the future, to avoid septic tanks and wells above the city. Councilmember Stallings suggested we start looking into the costs of providing these services up there.

Motion: To not allow the connection into the spring line unless they have documentation proving they have a previous agreement with the city. With the option that it will be revisited down the road.

Paul Madsen—questioned if a decision has been made on the storm drain. City was waiting for a response from the School District.

9. Report by City Council Members

Justin Atkinson—Nothing other than a thought about the irrigation project. He mentioned someone wanting to sell an irrigation well to the city. Would it make sense to buy it and hook it into the city irrigation? Mayor thinks we should investigate it.

Kevin Stallings—Appreciated the newsletter and recognizing the 4th of July Celebration participants, he also appreciated that it mentioned those working on the flower beds. Requested the water be checked on the city flower beds.

Wondered what it would take to put some new restrooms, or restore the ones we have at the city park? He suggests building one that is heated and available for use year-round. Councilman Atkinson suggested looking into a whole new makeover for our city park. Councilman Stallings & Atkinson will investigate what can be done to improve the park.

Russell Keisel—Stephanie has been hard to catch up to. Last time he talked to her; the recreation program was running well.

Aquatic center has swimming lessons going on. They open the doors to let people out onto the splash pad, but the water is not on to the fixtures.

Rondy Black—He mentioned that 400 East looks great. He has spoken with neighbors and others in town and they all seem pleased. Suggested some street signs (stop/yield) need to be placed around the new road and other streets in town.

Sam Draper—handed out papers on Fire Danger. Right now, things are dangerous and scary. Fireworks, fires, shooting, etc. are all banned right now, outside the city limits.
